



Notice is hereby given that sealed bids will be received by the Auburn Township Board of Trustees, c/o Fredrick May, Fiscal Officer, 11010 East Washington Street, Chagrin Falls, Ohio 44023-5556 until 4:00 P.M. official local time on April 6, 2015. Bids received will be publicly opened and read aloud at 7:45 P.M. the same day at the Auburn Township Administration Building for **The Reconstruction and Asphalt Resurfacing of Sections C and D of Stafford Road, TR 187**. The Engineer's estimate for this project is \$1,000,000.00

A bid guaranty in the amount of one hundred (100%) percent of the bid amount or a certified check, cashier's check or letter of credit pursuant to Chapter 1305 of the Ohio Revised Code in the amount of ten (10%) percent of the total bid amount shall accompany each bid. The bid shall be let upon a unit price basis.

Bids may be held by the Auburn Township Board of Trustees for a period not to exceed sixty (60) days from the date of opening, for the purpose of reviewing the bids and investigating the qualifications of bidders, prior to awarding the contract.

The Auburn Township Board of Trustees reserves the right to reject any and all bids, to waive any informalities or irregularities in the bids received, and to accept any bid or bids which are deemed most favorable to the Board at the time and under conditions stipulated, all in accord with the applicable provisions of laws of the State of Ohio governing the conduct of the Auburn Board of Township Trustees.
