Held ___ The meeting of the Auburn Township Board of Trustees was called to order at 7:30 p.m. by Chairman John A. Eberly. All Trustees were present.

The Pledge of Allegiance was led by Carl Schneider.

Mr. Cavanagh was sworn into office. Mr. May administered the Oath of Office.

Motion by Michael S. Troyan seconded by Patrick J. Cavanagh to approve the minutes of the Organizational Meeting of the Board of Trustees held on January 6, 2020. VOTE: Troyan, yes; Cavanagh, yes; Eberly, yes. The motion passed.

REPORTS:

Chief John Phillips, A.V.F.D., reported 36 calls year to date and gave the following year-end totals for 2019:

- 251 fire calls
- 404 EMS calls
- 655 calls for the year
- Responded to 144 calls for mutual aid
- Received mutual aid for 60 calls
- 262 transferred (3 were to helicopters)

Chief Phillips spoke to the annual pancake breakfast. Boy Scout Troop 101 will host the pancake breakfast this year on MARCH 1, 2020. It will be held at the Fire Station from 8:00am to 12:00 noon.

Michael S. Troyan reported correspondence from NOPEC awarding Auburn Township \$20,200.00 from their Energized Community Grant. The NEC grants are offered to help implement energy efficiency or energy infrastructure projects that will benefit our community. Mr. Troyan noted the AVFD used \$11,646.00 of the township's 2019 NEC grant to convert part of the fire station to LED lighting. They are hoping to get more funding from this year's NEC grant to complete the LED swap out.

The Trustees will take action on this at the next meeting when they have a quote for the final completion of the fire station's LED Conversion Project.

Patrick J. Cavanagh spoke to the Geauga County General Plan and thanked Craig Sirna for volunteering his time to serve on the Steering Committee established to represent Auburn's district during the Geauga County General Plan Update.

Fredrick May, Fiscal Officer, presented an Appropriations Report, Fund Status Report, Revenue Report and a Payment Report listing warrants 5626 through 5639 for a total of \$32,985.41. Mr. May spoke to a membership invite to the Coalition of Large Urban Townships (CLOUT).

Motion by Patrick J. Cavanagh seconded by Michael S. Troyan to join CLOUT and submit the \$200.00 membership fees. VOTE: Troyan, yes; Cavanagh, yes; Eberly, yes. The motion passed.

John A. Eberly spoke to the latest weather events and use of salt. A starter motor went in one of the trucks.

OLD BUSINESS:

The Trustees discussed the NatureWorks grant for the park pavilion.
