Under old business, schedule of uses was tabled. Under new business the Commission began reviewing the combined comments regarding Car Washes. Discussions took place.


Under Miscellaneous, the next meeting will be February 13, 2020. There was a public comment regarding the status of the proposed Redwood project. A short discussion took place.
