The Regular meeting of the Auburn Township Board of Trustees was called to order at 7:30 p.m. by Chairman Michael S. Troyan. Patrick J. Cavanagh and Michael S. Troyan were present and John A. Eberly participated digitally through Zoom.

The Pledge of Allegiance was led by Chief John Phillips.

Motion by Michael S. Troyan seconded by Patrick J. Cavanagh to approve the minutes of the Regular Meeting of the Board of Trustees held on February 17, 2021. VOTE: Eberly, yes; Cavanagh, yes; Troyan, yes. The motion passed.

GUESTS:

Stephen Szanto and Greg Van Wagnen from Sudsina & Associates, LLC were present to speak to refinancing Auburn's fire department and service department building loans. Stephen has 40 years in public finance and municipal advising.

Steve explained the two types of processes. The first is where the refinances are placed for public offering. This requires audited financial statements and could take 90-120 days and lots of man power to complete. Private placement, option 2, would take approximately 6-9 weeks. Time is of the essence as interest rates are volatile.

Mr. Szanto explained rates are usually lower in a public offering as you have more people bidding on the loan; but private placement will still result in the township getting a lower rate. His company will help put together a financial package and get the best bid we can.

Greg Van Wagnen presented graphics showing the increases and decreases in bond rates. We are currently in the lowest rate environment in history. There has been a slight increase in rates due in part to the COVID vaccinations and the job market should improve. There is also some pent up spending.

The Trustees will take this under advisement.

Motion by Patrick J. Cavanagh seconded by Michael S. Troyan to authorize the Fiscal Officer to pursue refinancing through Sudsina & Associates, LLC. VOTE: Eberly, yes; Cavanagh, yes; Troyan, yes. The motion passed.

Motion by Michael S. Troyan seconded by Patrick J. Cavanagh that the Fiscal Officer may come back to the Board of Trustees if staffing help is needed to expedite the refinancing. VOTE: Eberly, yes; Cavanagh, yes; Troyan, yes. The motion passed.

REPORTS:

Emerick Gordon, Township Highway Superintendent, gave the following report for February:

- February saw 12 weather events that required 19 rounds of plowing and or salting. The total amount of deicing material used was 485 tons. The monthly average is 515 tons. We are running just at average for the winter season. Our dome currently has ~550 ton of road salt. The remaining balance to the 2020 / 2021 contract, 1400 tons, will be purchased and stored giving us a full dome to begin the next winter service season.
- The tree removal for the Stafford Rd. OPWC Reconstruction Project began and is near completion. The timeline for bid opening is April 19th and shall take place during the Auburn Township Trustees Meeting at the Auburn Administration building. Also bid openings for the paving of various roads will take place at this meeting.
- Roads will be re-rated this spring and our Crack Seal Program will be crafted and put out to bid in the near future.

REPORTS (continued):

The 33% reduction in load limit signs were posted as per the Geauga County Board of Commissioner's. These will remain posted until released by the county.

Frank Kitko, Zoning Inspector, presented his zoning report for February reflecting 13 applications received and 13 permits issued. Year to date is 16 permits including 1 single family dwelling.

Patrick J. Cavanagh presented a Mutual Aid Agreement given to him by our Assistant Prosecutor. He explained this agreement is between South Russell, Russell, Bainbridge and Chagrin Falls and Bainbridge Township suggested Auburn Township might be interested in joining.

Trustee Cavanagh brought up the issues of distance going into another county.

Discussion ensued.

Michael S. Troyan noted we sustain minimal staffing would not be able to commit a lot of support. John A. Eberly said we already have an informal reciprocal agreements with neighboring service departments. Emerick Gordon added we have worked together with other townships on a case by case basis.

The Trustees were in agreement that our informal agreements are working well. We will decline a formal agreement at this time.

Patrick J. Cavanagh announced the Auburn Community Church would like to donate \$150,000.00 to the township. They would like to earmark \$75,000 to the Auburn Museum and \$75,000 to the Auburn Cemeteries. Trustee Cavanagh thanked the Church members for their generous donation.

We will forward the donation agreement to the Prosecutor's office for her review.

Mr. Cavanagh spoke to forming an Internet Research Committee and our request for letters of interest to serve on the committee. Nine residents were interested in being on the research team. The Board of Trustees would like to see them pursue the following areas:

- Focus on our current primary provider.
 Look at other providers in the township.
- 3. Look into getting new providers for the township.

The township will cover the cost to make copies of needed documents, offer the use of a facility to hold their meetings and help facilitate Zoom meetings if needed. The following residents were appointed to the committee: Ted Van Hyning, Craig Sirna, Adam Elsoffer, Tom Manning, Ray Somich II, Martin Mensch, Kevin Ortner, Scott Trimmer and Craig Hyps.

Michael S. Troyan will check with our prosecutor to see if the committee has to be run according to the Sunshine Law. We will contact the volunteers listed above and ask them to attend the next Board of Trustees meeting on March 15, 2021 either in person or digitally through Zoom.

John A. Eberly presented a quote from JFD Landscapes for the bed maintenance, flower planting, fertilizing and cutting of 9 township properties. There was a new quote for \$11,624.52 for mowing the entrance and exit ramps at SR44 and RT422. Discussion ensued.

Motion by Patrick J. Cavanagh seconded by Michael S. Troyan to accept the quote and contract with JFD Landscapes for a total of \$39,932.40 for the 2021 and 2022 maintenance of 9 township properties. VOTE: Eberly, yes; Cavanagh, yes; Troyan, yes. The motion passed.
