The REGULAR MEETING of the Auburn Township Board of Trustees was called to order at 7:30 p.m. by Vice Chairman, Patrick J. Cavanagh. Trustee Patrick J. Cavanagh and Trustee Michael S. Troyan were present and John A. Eberly participated digitally through

The Pledge of Allegiance was led by Mario Manacci.

Motion by Michael S. Troyan seconded by Patrick J. Cavanagh to approve the minutes of the Regular Meeting of the Board of Trustees held on December 7, 2020. VOTE: Eberly, yes; Troyan, yes; Cavanaugh, yes. The motion passed.

### **GUEST:**

Mr. Manacci, AVFD Corporation President, presented the 2021 Fire Services Contract.

Motion by Michael S. Troyan seconded by Patrick J. Cavanagh to execute the 2021 Fire Services Contract as presented and attached. VOTE: Eberly, yes; Troyan, yes; Cavanagh, yes. The motion passed.

The Trustees discussed the CARES ACT FUNDING Sub-grant to the AVFD.

Motion by Patrick J. Cavanagh seconded by Michael S. Troyan to enter into subgrant agreement as presented and attached with the AVFD in the amount of \$ 208,355.11 for the purchase of a COVID ambulance. VOTE: Eberly, yes; Troyan, yes; Cavanagh, yes. The motion passed.

## **SCHEDULED REPORTS:**

Chief John Phillips, AVFD, gave a report indicating 809 calls to date. That number is up 170 calls from last year to date. He thanked the Road Department for their help with the fire event on St. James.

Michael Ludwig, Auburn Road Department, discussed department needs. He presented a request for the following Road and Bridge purchases totaling approximately \$94,442.00:

- 1. Cement saw \$11,967.00
- 2. Chipper \$49,700.00
- 3. Radios \$14,600.00
- 4. RTV \$14,748.00
- Tires for backhoe and mower \$3,427.00

Discussion ensued about each presented item individually.

Trustee Cavanagh noted additional Road and Bridge funds will be added to the OPWC Stafford Road Improvement Project next year to avoid intrusion into residents yards.

Michael Ludwig presented specs and recommended a Corecut cement saw.

Motion by Michael S. Troyan seconded by Patrick J. Cavanagh to purchase the recommended Corecut CC2500 cement saw in the amount of \$11,967.00. VOTE: Eberly, yes; Troyan, yes; Cavanagh, yes. The motion passed.

Motion by Patrick J. Cavanagh seconded by Michael S. Troyan to purchase new tires for the backhoe and mower from Goodyear at a cost of \$3,427.00. VOTE: Eberly, yes; Troyan, yes; Cavanagh, yes. The motion passed.

Mr. Ludwig presented advantages of having an RTV and presented specs and recommended a Kubota.

We will not be allowed at this time, to have public access to the water. It will be used for cleaning and sanitizing only.

Fredrick May, Fiscal Officer, presented an Appropriations Report, Fund Status Report, Revenue Report and a Payment Report listing warrants 6163 through 6192 for a total of \$392,664.48 along with Resolution 2020-41, Resolution 2020-42 and Resolution 2020-43.

Motion by Patrick J. Cavanagh seconded by Michael S. Troyan to adopt Resolution 2020-41 authorizing Fiscal Officer to request a Tax Advance for Fiscal Year 2021. VOTE: Eberly, yes; Troyan, yes; Cavanagh, yes. The motion passed.
