The meeting of the Auburn Township Board of Trustees was called to order at 7:30 p.m. by Chairman Michael S. Troyan. Trustee Patrick J. Cavanagh and Trustee Michael S. Troyan were present and John A. Eberly participated digitally through Zoom.

The Pledge of Allegiance was led by Craig Sirna.

# **INTERNET RESEARCH COMMITTEE:**

Mr. Troyan explained that the Trustee's actions of formally appointing an internet research committee would actually be counterproductive and not allow the township to accomplish what we had wanted.

Motion by Michael S. Troyan seconded by Patrick J. Cavanagh to dissolve the internet research committee appointments. VOTE: Eberly, yes; Cavanagh, yes; Troyan, yes. The motion passed.

Trustee Troyan thanked the nine member citizens group who will continue to look into resources to improve township internet availability. He assured the group the Board of Trustees will support them from here on out in whatever way possible.

Mr. Sirna asked if the township needed the money received from the franchise fees and wondered if it was possible we could use it towards a build out of internet infrastructure. Craig Hyps asked if the goal of the citizens committee would be to get a better provider.

Further discussion ensued. Trustee Eberly volunteered to be Trustee liaison with the citizens group.

Motion by Patrick J. Cavanagh seconded by Michael S. Troyan to allow the citizens committee use of any township facilities for their meetings. VOTE: Eberly, yes; Cavanagh, yes; Troyan, yes. The motion passed.

Motion by Patrick J. Cavanagh seconded by Michael S. Troyan to approve the minutes of the Regular Meeting of the Board of Trustees held on March 1, 2020. VOTE: Troyan, yes; Cavanaugh, yes. The motion passed.

### REPORTS:

Chief John Phillips, presented the April report for AVFD.

Patrick J. Cavanagh addressed the proposed donation agreement from the former Auburn Community Church and our assistant prosecutor's comments to the agreement. Some terms on the document were too broad, such as the township's commitment to pay "all fees" related to the donation. According to the ORC, we cannot legally commit to unknown fees. Mr. Cavanagh will take the prosecutors updates back to the church committee for their approval.

John A. Eberly reported the Road Department is winding down from winter services. He noted they did a good job without a lot of overtime. Currently the department is working on getting the salt dome filled. He presented an agreement with ODOT to execute.

Motion by Michael S. Troyan seconded by Patrick J. Cavanagh to adopt Resolution 2021-11 Authorizing Participation in the ODOT Road Salt Contracts Awarded in 2021 and agreeing to purchase 1500 tons of salt at a cost and from a supplier to be determined by competitive BID. VOTE: Eberly, yes; Cavanagh, yes; Troyan, yes. The motion passed.

Trustee Eberly spoke to the soon expected delivery of the department's new truck and stated we will sell the older truck on GovDeals. He reported berm work has started on Valley Road. Some cold patching has been done around the township and soon we will be able to start hot mix patches.

# RESOLUTION 2021-11 AUTHORIZING PARTICIPATION IN THE ODOT ROAD SALT CONTRACTS AWARDED IN 2021

WHEREAS, AUBURN TOWNSHIP, GEAUGA COUNTY (hereinafter referred to as the "Political Subdivision") hereby submits this written agreement to participate in the Ohio Department of Transportation's (ODOT) annual road salt bid in accordance with Ohio Revised Code 5513.01(B) and hereby agrees to all of the following terms and conditions in its participation of the ODOT road salt contract:

- a. The Political Subdivision hereby agrees to be bound by all terms and conditions established by ODOT in the road salt contract and acknowledges that upon of award of the contract by the Director of ODOT it shall be bound by all such terms and conditions included in the contract; and
- b. The Political Subdivision hereby acknowledges that upon the Director of ODOT's signing of the road salt contract, it shall effectively form a contract between the awarded salt supplier and the Political Subdivision; and
- c. The Political Subdivision agrees to be solely responsible for resolving all claims or disputes arising out of its participation in the ODOT road salt contract and agrees to hold the Department of Transportation harmless for any claims, actions, expenses, or other damages arising out of the Political Subdivision's participation in the road salt contract; and
- d. The Political Subdivision's electronic order for Sodium Chloride (Road Salt) will be the amount the Political Subdivision agrees to purchase from its awarded salt supplier at the delivered bid price per ton awarded by the Director of ODOT; and
- e. The Political Subdivision hereby agrees to purchase a minimum of 90% of its electronically **submitted** salt quantities from its awarded salt supplier during the contract's effective period; and
- f. The Political Subdivision hereby agrees to place orders with and directly pay the awarded salt supplier on a net 30 basis for all road salt it receives pursuant to ODOT salt contract; and
- g. The Political Subdivision acknowledges that should it wish to rescind this participation agreement it will do so by written, emailed request by no later than Friday, April 30 by 5:00 p.m. The written, emailed request to rescind this participation agreement must be received by the ODOT Office of Contract Sales, Purchasing Section email: <a href="mailto:Contracts.Purchasing@dot.ohio.gov">Contracts.Purchasing@dot.ohio.gov</a> by the deadline. The Department, upon receipt, will respond that it has received the request and that it has effectively removed the Political Subdivision's participation request. Furthermore, it is the sole responsibility of the Political Subdivision to ensure ODOT has received this participation agreement as well as the receipt of any request to rescind this participation agreement. The Department shall not be held responsible or liable for failure to receive a Political Subdivision's participation agreement and/or a Political Subdivision's request to rescind its participation agreement.
