The meeting of the Auburn Township Board of Trustees was called to order at 7:30 p.m. by Chairman John A. Eberly. Two Trustees were present.

The Pledge of Allegiance was led by Chief Phillips.

Motion by Patrick J. Cavanagh seconded by John A. Eberly to approve the minutes of the Regular & Special Meeting of the Board of Trustees held on July 6, 2020. VOTE: Cavanagh, yes; Eberly, yes. The motion passed.

REPORTS:

James Dixon, Construction Manager, gave an update on the pavilion project. Permits should be ready next week.

Chief Phillips reported the AVFD has responded to 419 calls this year as compared to 329 calls last year to date. He updated the Trustees on the repairs to the generators at the station and service garage.

Mario Manacci, AVFD Board President, made a presentation on behalf of the AVFD. They explained the need for additional funding to staff all shifts, keep up with continuous growth and increased call load, and the need to replace equipment. Improvements, including increased staffing, could improve the Fire Department's ISO rating and lead to lowering resident's homeowner's insurance.

The Trustees asked several questions about the number of calls and the cost of operations. John A. Eberly asked about EMT calls verses Fire calls. The focus of the discussion was on additional staffing.

Dan Matsko, AVFD Board Treasurer, confirmed the department ran at a \$60,000 deficit last year.

The Trustees agreed that staffing the station, as opposed to responding from home, has helped response times.

Trustee Eberly said we should focus on response times, not ISO ratings although lowering ISO is still an aspiration.

Trustee Cavanagh inquired about a breakdown of how much of the contract increase is going to staffing and how much to equipment.

Dan Matsko and Mario Manacci confirmed it would be over 60% going toward staffing. The proposed increase would cover an additional man per shift. They are looking at 7-8 new

A discussion ensued about AVFD's responsibility to communicate their needs to the public.

Fred May, Auburn Fiscal Officer, stated we are looking a 1.8 mill levy to cover increase contract and increased maintenance and administrative costs. The levy will have to be considered at the next Meeting of the Board on August 3, 2020.

Patrick J. Cavanagh reported that the American Red Cross has a blood drive at Adam Hall tomorrow. They have notified us that they will not be able to use most of their school sites for blood drives due to COVID-19. They have inquired if Adam Hall would be available for more dates later this year.

John A. Eberly reported the Cruz Air ditching machine has been sold on GOV DEALS for \$8,200. We paid \$7,500 for it.

The Road Department would like to buy a "wrist" for the mini-excavator to be able to turn the bucket making it more efficient to do ditching. The Trustees are in favor of this and will seek quotes.
