# TOWN HALL REGULATIONS

1. Rental cost for the Town Hall is \$50.00 for 4 hours for Auburn Township residents and \$100 for 4 hours for out of township residents. Additional hours available for \$10 per hour for residents and \$20 per hour for out of township residents.
2. The air conditioned facility has three 8' rectangle tables, seven 60' round tables, 50 chairs, 50 cup coffee maker, refrigerator, stove, and microwave.
3. Maximum occupancy is 50 people
4. NO ALCOHOLIC BEVERAGES ARE PERMITTED
5. The building is to be vacated by 11:00 PM
6. The heat control thermostat is to be turned to **65** Fahrenheit upon vacating the building.
7. The air conditioner thermostat is to be turned **OFF** upon vacating the building.
8. Interior lights are to be turned **OFF** upon vacating the building.
9. Renter is to sweep floor, wipe counter tops, clean spills and leave the facility in the same(or better) condition than when rented.
10. All trash is to be removed upon vacating the building and a new bag put in garbage container for the next renter. Bags and extra toilet paper can be found in the kitchen cabinets. You may drop your trash off at the Auburn Service Garage, 17666 Auburn Road (behind the Auburn Fire Station).
11. No grease-producing products shall be cooked in the kitchen area of the Town Hall.
12. No holes are to be made in the walls or ceiling to hang decorations or displays.
13. Tables must be covered and protected when used for eating and/or crafting.
14. Inventoried tables and chairs are not to be removed from the building.
15. Key must be deposited in the Administration Building key box after Town Hall use.
16. The Geauga County Sheriffs' Department has authority to enter Town Hall at any time.

**\*Note:**

Please be aware there is **no telephone** installed at Auburn Township Town Hall. A personal cell phone would be needed to call 911 for an emergency.

**Parking:**

Parking must be confined to the Town Hall lot to the west fence line. (The parking area west of the fence line is private property) **The renter will be fined \$50.00 and vehicle** may be subject to towing at the owners expense if any vehicle is parked west of the fence. Additional parking is available at the Administration Building, 11010 Washington Street.
