## **REPORTS:**

**Frank Kitko, Zoning Inspector,** submitted a Zoning report reflecting 9 permits processed in the month of October. Two were for single family dwellings. He noted he has been working with the Zoning Commission on some Amendments.

Emerick Gordon, Township Highway Superintendent, presented the following report for October.

- The month's agreeable weather was taken advantage of and the patching of potholes was addressed with cold patch and hot mix asphalt. We have one subdivision left to inspect and do repairs.
- The roadside mower was out and took one final pass prior to winter. There was one downed tree on Shaw road as well as some brush clearing around signs.
- One driveway culvert pipe was replaced on Waterford Tr., this brings our residential ditch requests down to 5 left for the year.
- There were 3 urn burials for the month at the cemeteries.
- The trucks and equipment are being gone over for winter service. Truck 16 is currently at Rush Truck Center for an intermittent transmission problem. Truck 15 will be having its oil pan replaced in house as well as oil and filter changes for trucks 16, 17 and 18.
- Letters were sent out to residents concerning the suspension of the Stafford Rd. Reconstruction Project until next spring. This will ensure a hard surface for our plow drivers to maintain and the ability to apply deicing materials.

Motion by John A. Eberly seconded by Michael S. Troyan to purchase Berm-O-Matic at a cost not to exceed \$5,000. VOTE: Eberly, yes; Cavanagh, yes, Troyan, yes. The motion passed.

John A. Eberly reported on the progress of Windstream Broadband Development. The next step would be to partner with the County for greater access to funds to upgrade the township's accessibility to DSL and/or fiber.
