The meeting of the Auburn Township Board of Trustees was called to order at 7:30 p.m. by Vice Chairman Patrick J. Cavanagh. Two Trustees were present.

GUESTS:

Eleana Dewitt, Kenston Girl Scout, is working to achieve her Silver Award, the highest award a cadet can earn. She proposed her community project of designing and planting a wildflower garden to the Board.

Eleana gave a power point presentation about wild flower gardens. She explained they are an extremely valuable habitat to bees, moths, butterflies and insects. Bees and other pollinators are essential to the production of fruit and vegetable crops. Eleana requested permission from the Board of Trustees to locate her project at Auburn Community Park, but was also receptive to any other location suggested by the Board.

Patrick J. Cavanagh thanked her and complimented her on the execution of her presentation. The Trustees discussed specific locations at the park for the garden.

Motion by Patrick J. Cavanagh seconded by Michael S. Troyan to approve Auburn Community Park as the location of Eleana Dewitt's wild flower garden. VOTE: Troyan, yes; Cavanagh, yes. The motion passed.

Chris Louis was present representing the Auburn Boy Scout Troop #101. The Scouts have taken over the responsibility of organizing the annual 4th of July Parade and Picnic. Matt England is the official event organizer. The event takes place on Monday, July 4th. The staging takes place at 10:00 a.m. at The Meadows subdivision off Auburn Road. The parade will commence at 11:00 a.m. heading south on Auburn Road, and west on Washington Street. The final destination will be the Auburn Fire Station. Hot dogs and beverages will be available and profits go directly to the Boy Scouts and Cub Scouts. Mr. Lewis asked that we post it on the township website.

The Trustees thanked Mr. Louis.

REPORTS:

Frank Kitko, Zoning Inspector, submitted a zoning report reflecting 10 applications processed in the month of May resulting in 10 permits issued. He reported procedure seems to be changing with the County Offices. He spoke about a current case that was approved by planning before Auburn Zoning approved the application.

Mr. Troyan agreed procedures needs to be worked out between departments.

Emerick P. Gordon, Township Highway Superintendent, gave the following report for May:

- Patching continued on various roads and partial depth repairs were made on Moreland Lane. Preliminary discussions concerning the condition of Moreland Lane between Trustee Cavanagh, myself and the county were had and further investigation is needed before determining the surfacing schedule and type.
- There were several trees down due to high winds, the road department did respond to two of the calls. Also beaver dams were removed from the roadside ditch along Crackel Rd.
- Two weeks were spent in the cemeteries clearing brush, overgrowth, leveling gravesites, seeding, and pouring footers. The old split rail fence was also removed in anticipation of the new fencing.
- Roadside mowing was started and we are currently waiting on parts to be delivered so we can continue with the service.
- We did do a couple small ditching requests on Stafford Rd. and erosion control on Quinn Rd. Will be addressing resident requests when we have the opportunity.

REPORTS (continued):

Discussion followed regarding tall weeds at the park starting to reseed. Trustee Cavanagh suggested it might be best to look into renting equipment to cut the park while we are awaiting the unavailable part to fix our mower.

Mr. Cavanagh reported the Road Department is focusing on the Chip Seal Project and the Crack Seal Project. The Crack Seal Project has an estimated budget of \$50,000 and will be bid out as a line item bid listing all roads rated 5 & 6. The legal ad runs on June 16th and the bid deadline and opening is Tuesday, July 5, 2022.

Nine roll-off dumpsters were used at the Large Item Trash Drop-Off Event and the Sr. Resident Trash Pick-Up Event compared to 13 dumpsters last year. We had a smaller than usual crowd. One hundred senior residences participated in the Pick-Up Event.

Fredrick May, Fiscal Officer, was not present.

Michael S. Troyan spoke to the AVFD working on prioritizing their list of projects that qualify for ARPA funds.

Patrick J. Cavanagh discussed recommendations from the Geauga County Engineer.
