The meeting of the Auburn Township Board of Trustees was called to order at 7:30 p.m. by Chairman Eugene T. McCune Jr. All Trustees were present.

The Pledge of Allegiance was led by Dan Matsko.

Motion by Michael S. Troyan seconded by Patrick J. Cavanagh to approve the minutes of the Regular Meeting of the Board of Trustees held on August 1, 2022 as amended. VOTE: Troyan, yes; Cavanagh, yes; McCune, yes. The motion passed.

REPORTS:

Patrick J. Cavanagh addressed the proposed changes to the Zoning Resolution 2022-02 with modifications.

Motion by Patrick J. Cavanagh seconded by Michael S. Troyan to approve and adopt Zoning Resolution ZC2022-02 with modifications. VOTE: Troyan, yes; Cavanagh, yes, McCune, yes. The motion passed.

Chief John Phillips, AVFD, presented a July YTD statistics report comparing 485 calls in 2022 to 473 calls in 2021. The percentage of multiple calls was 20.20% in 2022 versus 23.89% in 2021.

Chief Phillips announced the annual AVFD Clambake will be held on September 10th from 6:00pm - 8:30pm. The dinners are \$35 and includes a dozen clams, ½ chicken, ear of corn, yam, coleslaw and roll. Michael S. Troyan attended the DTJ Harvest Festival and participated in the festival's parade.

Patrick J. Cavanagh spoke to the COVID spread. He noted we are on schedule for the submission of the 2023 Road Project list to the Geauga County Engineer's office.

Trustee Cavanagh reported equipment from a residential lumber delivery raised a lot of issues with a newly surfaced township roadway.

He reported a resignation on the Board of Health. There is a Health Board Meeting in September that P.J. Cavanagh will attend.

Eugene T. McCune Jr. addressed the loss of Auburn residents Dorothy Papp and Ken Gibb. He spoke to Mr. Gibb's civic involvement.

Trustee McCune Jr. met with Shane from Western Reserve Land Conservancy (WRLC) and did a walk-through at Auburn Community Park.

Two Auburn Scouts from Troop 101 had their Court of Honor Ceremony at the park pavilion on Sunday, August 14th. Congratulations to Nicholas Snider and Luca Buonamici for obtaining Eagle Scout status.

Mr. McCune Jr. walked the cemeteries and reviewed headstone restoration possibilities. He also addressed a call from a resident about a headstone that faces west. He proposed instituting a new rule that all headstones face east.


