The Regular meeting of the Auburn Township Board of Trustees was called to order at 7:30 p.m. by Chairman Eugene T. McCune Jr. All Trustees were present.

The Pledge of Allegiance was led by Emerick Gordon.

Motion by Michael S. Troyan seconded by Patrick J. Cavanagh to approve the minutes of the SPECIAL Meeting of the Board of Trustees held on December 1, 2022. VOTE: Troyan, yes; Cavanagh, yes; McCune Jr., yes. The motion passed.

Motion by Michael S. Troyan seconded by Patrick J. Cavanagh to approve the minutes of the Regular Meeting of the Board of Trustees held on November 21, 2022. VOTE: Troyan, yes; Cavanagh, yes; McCune Jr., yes. The motion passed.

GUESTS:

Keith Blazer, Auburn Fire Secretary, presented the department's budget. Trustee Troyan spoke to the 2023 proposed AVFD contract and our options to incorporate ARPA funds. There are 2 options:

- 1. Accept the AVFD contract "as is" and amend it at a later date.
- 2. Incorporate ARPA funds in the contract as line items for each proposed expenditure.

The Trustees prefer option #2. Michael S. Troyan requested the AVFD make the changes and submit it to the prosecutor's office for approval in time for the December 19th meeting.

REPORTS:

Frank Kitko, Zoning Inspector, submitted a zoning report reflecting 9 applications processed in the month of November resulting in 7 permits issued. He also reported a resident has requested a variance for a second dwelling on the property operating as a B & B. Discussion ensued about home owners associations in developments.

Emerick P. Gordon, Township Highway Superintendent, gave the following report for November:

- The month saw three weather events that required three rounds of plowing and or salting. A total of 79 tons of deicing material was used. This puts the monthly average use for November at 94 tons. Currently we have ~ 1721 tons of road salt in the dome.
- With agreeable weather early in the month we were able to do some asphalt patching on various roads. Sixteen tons of hot mix asphalt was used. Some cold patching was done as well and will continue when time and weather allow.
- One failed driveway culvert pipe was replaced on Marydale Dr.
- High winds did bring down some limbs and branches midmonth which were removed from the roadways.
- Equipment and trucks were serviced and readied for winter snow removal and deicing.

Patrick J. Cavanagh presented Resolution 2022-42 and Resolution 2022-43.
