The meeting of the Auburn Township Board of Trustees was called to order at 7:30 p.m. by Chairman Patrick J. Cavanagh. All Trustees were present.

The Pledge of Allegiance was led by Kaye Repke.

**Motion by Eugene T. McCune Jr. seconded by Michael S. Troyan to approve the minutes of the Regular Meeting of the Board of Trustees held on November 6, 2023, with correction. VOTE: Troyan, yes; McCune Jr., yes; Cavanagh, yes. The motion passed.**

Present was Auburn resident, Kay Repke, who is interested in serving on one of the 2024 Zoning Boards. Trustee Cavanagh explained the position and requirements. Kaye stated that she is flexible for either position. She currently works with non-profits.

**REPORTS:**

**Chief John Phillips, AVFD**, presented a Year-to-Date Statistics Report comparing 745 calls in 2023 to 698 calls in 2022. The percentage of multiple calls was 25.36% for January –October 2023.

**Michael S. Troyan** presented the 2024 Auburn Volunteer Fire Department Contract to be signed in December. They requested a 3.2% increase amounting to \$34,324.00. The current contract rate is \$1,050,763.50. With the 3.2% increase, the contract quote comes to \$1,084,387.90. Fire Department representatives will be present at the next meeting to share their 2023 achievements.

**Eugene T. McCune Jr.** passed on his report.

**Patrick J. Cavanagh** reported the township sponsored Cub Scout Pack 101 will not charter next year. The Cub Master is moving up to Boy Scouts and several attempts to find a volunteer replacement has failed. The Boy Scouts offered to be their bank and earmark their generous Auburn Church donation to the Cub Scouts when the Pack revives and recharter.

Trustee Cavanagh attended an OPWC meeting last week at the Engineer's office. Mantua is interested in joining efforts to pave shared township roads. Mr. Cavanagh spoke to a request from ODOT to detour Stafford Road, westbound, for one of their projects next year. Emerick Gordon, Highway Superintendent, will explain at the next meeting of the Board.

**Daniel J. Matsko, Deputy Fiscal Officer**, presented a payment report listing electronic warrants 145-2023 through 153-2023 and warrants 8081 through 8093 for a total of \$87,836.63.

NOPEC grant unused balance is \$30,378.00 from 2022 & 2023.

**NEW BUSINESS:**

Dan Matsko presented Resolution 2023-33.

Mr. Matsko presented the Delta Dental 2024 contract.






Troy Township residents came to view our meeting. They commented that we were very organized.
