It is understood that the group or organization using the Auburn Community Park Pavilion will comply with the laws of the State of Ohio, the Township of Auburn and all rules and regulations set forth by the Auburn Township Board of Trustees, and:

1. Lessee is responsible for all persons in their group/organization.
2. The park and pavilion may be used daily from dawn to dusk.
3. No staples, nails, tacks or tape are to be used to fasten any material to the walls, ceiling, or beams.
3. Alcoholic beverages are not permitted. Dogs must be leashed.
4. Lessee shall be responsible for cleanup after event. All refuse must be deposited in park containers or taken with you. Lessee will be fined for trash bags left out exposed to the elements and wild critters.
5. The Township is not responsible for lost, stolen, or left articles.
6. Lessee assumes all liability for any damage done to the facility.
7. If reservation is cancelled within 30 days of event, rental fee will be forfeited.
8. Refund for cancellations will not be considered for inclement weather on the day of rental.
9. The pavilion must be returned to its original condition:
  - a. If tables are used, they must be cleaned
  - b. All decorations must be removed.
10. The security deposit will be returned after the event by U.S.Mail, less an amount sufficient to cover any damages or outstanding fees and/or additional costs due to the Township as a result of this function. (If damages must be assessed, the Trustees will determine an appropriate amount to be deducted).
