A RESOLUTION REQUESTING THE ESTABLISHMENT OF CAPITAL PROJECTS FUNDS PURSUANT TO AND AS ALLOWED BY OHIO REVISED CODE § 5705.13(C)

The Board of Trustees of Auburn Township, Geauga County, Ohio, met in general session on the 18th day of December 2023, at the Auburn Township Administrative building with the following members present: Patrick J. Cavanagh, Eugene T. McCune and Michael S. Troyan

WHEREAS, it is the desire of the Auburn Township Board of Trustees (the Board) that, pursuant to R.C. 5705.13(C) there be established within the appropriations of Auburn Township (the Township) a Capital Project Fund, more fully described below, for the purpose of accumulating resources for the acquisition, construction, or improvement of fixed assets of the Township; and

WHEREAS, it is the desire of the Board to establish "Fund 4903: Capital Project Fund – Single Axle Dump Truck with Plow" for the purpose of the acquisition, construction and/or improvement of fixed assets including, but not limited to, hauling materials and plowing snow. The Board intends to accumulate **\$240,000.00** over a 10-year period of time. The source of money to accumulate said monies for Fund 4903 is Fund 2021 Gasoline Tax and

WHEREAS, it is the desire of the Board to authorize an initial transfer of **\$60,000** from Fund 2021 to newly established Fund 4903; and

WHEREAS, money shall not be accumulated in any of the above referenced funds for more than 10 years after the date that this Resolution establishing the funds is adopted; if the Township has not entered into a contract for the acquisition, construction, or improvement of fixed assets for which money was accumulated in such fund(s) before then end of the 10 year period, the Township Fiscal Officer shall transfer all money in the fund to the fund or funds from which that money originally transferred or the fund that originally was intended to receive the money; and

WHEREAS, the Board has the authority, by resolution, to rescind any or all of the capital projects funds established by this Resolution. If any capital projects fund is rescinded, money accumulated in the fund shall be transferred to the fund or funds from which the money originally was transferred.

AGREEMENT

This Agreement made this eighteenth day of December, 2023 at Auburn, Ohio, by and between the Auburn Township Board of Trustees (hereinafter referred to as "Trustees") and the Auburn Volunteer Fire Department, Inc., an Ohio non-profit corporation (hereinafter referred to as "Corporation").

WITNESSETH:

Whereas, the Trustees are the duly elected officials of Auburn Township, and,

Whereas, the Trustees desire to provide fire protection and emergency medical service for Auburn Township as authorized under O.R.C. 9.60, and,

Whereas, Corporation is a non-profit corporation qualified to provide fire protection and emergency medical services for Auburn Township and has done so for many years, and,

Whereas, the parties desire to enter into an Agreement whereby Corporation shall provide fire protection and emergency medical service (urgent pre-hospital care, stabilization and/or emergency transportation to definitive care destinations) to Auburn Township and other communities with which Auburn Township has negotiated agreement for mutual aid, all of which is authorized under O.R.C. 9.60.

Therefore, in consideration of the terms and conditions set forth below, the parties agree as follows:

1. Trustees hereby agree to retain the services of Corporation for a term commencing January 1, 2024 and terminating December 31, 2024 to provide fire protection and emergency medical service to Auburn Township and other communities with which Auburn Township has entered into mutual aid agreements.

2. Corporation hereby agrees to provide fire protection and emergency medical service for a term commencing January 1, 2024 and terminating December 31, 2024 to Auburn Township and such other communities with which Auburn Township has entered into mutual aid agreements.

3. Trustees agree to pay Corporation for such services the sum of One Million, Eighty Four Thousand, Three Hundred Eighty Seven and 92/100 Dollars. (\$1,084,387.92). The payment schedule will consist of three (3) equal disbursements of Three Hundred Sixty One Thousand, Four Hundred Sixty Two and 64/100 Dollars (\$361,462.64) each, made on or before March 1, 2024, June 1, 2024 and September 1, 2024.

4. Corporation agrees to provide and maintain the necessary equipment together with trained personnel, which in its judgment is sufficient and adequate for the purpose of fighting fires, rescue and saving lives. Corporation further agrees to respond to all calls pertaining to fires, drowning and life-saving attempts within Auburn Township and any and all requests for mutual aid from communities with which Auburn Township has such agreements, as stipulated in those agreements. Corporation agrees to provide Trustees with copies of all such agreements.

P ... 3.

5. Corporation shall maintain insurance coverage for general liability, injuries to persons and property, and errors and omissions in an amount not less than One Million Dollars (\$1,000,000) per occurrence. The Township shall be named as an additional insured on said coverage. Corporation shall provide the Trustees with a certificate of proof of insurance in accordance with the terms herein. Corporation shall save the Township harmless from any claims of liability of injury to persons or property resulting from the acts or omissions to the Corporation, its officers, employees, or volunteers.

6. Pursuant to Ohio Revised Code 505.38B the board of township trustees shall appoint a fire prevention officer who shall exercise all of the duties of a fire chief except those involving the maintenance and operation of fire apparatus. Said fire prevention officer will investigate fires within Auburn Township and submit the required forms to the fire marshal as required by Ohio Revised Code 3737.24.

7. Corporation will provide at least one person to voluntarily serve as a fire safety inspector for the township. Such person shall have received a certificate issued pursuant to Ohio Revised Code 4765.55 evidencing his or her satisfactory completion of a fire safety inspector training program. The list of the person or persons who will act as fire safety inspectors will be furnished by Corporation to the Trustees along with copies of their qualification certificates issued pursuant to 4765.55. Any changes in the list shall be immediately reported by Corporation to the Trustees.

8. This agreement may be terminated by either party hereto. Termination shall be by one hundred and twenty (120) days written notice of such intention directed to the other party, but in no event shall either party terminate this agreement unless there is substantial breach of this Agreement.

9. Trustees represent they are authorized by statute to enter into this Agreement, and that to the best of their knowledge and belief this Agreement is valid.

10. Corporation represents that this agreement had been authorized by proper resolution of the Trustees of Corporation, a copy of which will be presented to the Trustees upon request.

11. Terms and conditions of the Agreement shall inure to the benefit of and be binding upon the successors and assigns of the parties hereto.

12. The Corporation agrees to negotiate for the Corporation and Trustees all mutual aid agreements. Any such agreement negotiated by the Corporation shall not be binding on Corporation or Trustees until adopted by appropriate resolution of the respective Corporation and Trustee Boards.

13. It is further mutually agreed that should any part, term or provision of this contract be decided by courts of the State of Ohio or of the United States to be unlawful or in conflict with any law of the State of Ohio or of the United States, the validity of the remainder of the entire contract or of the remaining portions or provisions of this contract shall not be affected thereby.

14. The Fire House building shall be exclusively used for daily operations and community events hosted or sponsored by the Auburn Volunteer Fire Department Inc. The Auburn Trustees may make use of the facility during emergencies.

15. Corporation hereby agrees that if, during the term of this contract, Corporation is dissolved or becomes unable to provide the services contracted for, all titled vehicles, firefighting, lifesaving rescue equipment, funds in corporation bank accounts, Township general fund monies, fire levy monies, EMS billing revenue & insurance claim monies will be turned over to Trustees to become the property of Auburn Township. The exception being association funds, which have not been attained with tax levy monies, which the Auburn Fire Department Association may hold, as defined by the bylaws of the corporation. Should this occur, the township assumes all liability associated with the function of the Fire Department.

16. Trustees hereby agree to continue to renew the contract with Corporation for all funds available from all township fire levies (excluding the agreed upon funds for maintenance for the fire department building and grounds) so that an orderly cash flow to Corporation is not interrupted.

17. Corporation hereby agrees that at any time during the term of this contract, Trustees may, by resolution and a majority vote of Trustees, request an audit of all funds generated by public fire levies assessed on taxpayers of Auburn Township. This shall be completed by a private licensed public accounting firm. The expenses incurred by the audit shall be paid for by Township general fund monies and not from fire levy monies, as the audit shall be requested by the Auburn Township Trustees. The Township shall compensate one Auburn Volunteer Fire Department Inc. representative for the representative's time spent during the complete duration of the audit at \$30.14 per hour.

18. Corporation hereby agrees to provide Trustees with a proposed fiscal budget for the upcoming year. This shall be done Thirty days before the ending of the enforced contract. Also Sixty days after the signing of said contract, an overview of the ending year shall be made available to the Trustees.

19. This contract shall be the sole and binding contract between the Auburn Township Trustees and the Auburn Volunteer Fire Department Inc., and shall supersede all previous contracts and documents.

20. This contract shall be construed and interpreted and the rights of the Parties determined in accordance with the laws of the State of Ohio. Any litigation arising hereunder shall be brought in a court of competent jurisdiction of Geauga County, Ohio.
