The meeting of the Auburn Township Board of Trustees was called to order at 7:30 p.m. by Chairman Michael S. Troyan. All Trustees were present.

The Pledge of Allegiance was led by Mr. John Szoka, a recently retired Auburn Township Road Department employee.

**Mr. Frank Kitko**, Zoning Inspector, submitted a Zoning report reflecting 10 applications submitted in the month of August.

**Mr. Eugene T. McCune Jr.** had nothing new to report.

**Mr. Patrick J. Cavanagh, Vice Chairman**, reported that he will contact resident Patty Carlton at 17650 Auburn Road, about the water problem(s) on her property, as brought up at the Trustee Meeting on August 19, 2024.

Mr. Frank Kitko noted that Patty Carlton had contacted him about the problems she is having, and he suggested she get a survey, so she knows her property boundaries.

Mr. Cavanagh also reported that the Trustees can conduct the interviews for the Road Department applicants in an Executive Session. The interviews will be conducted in a Special Meeting by the Board of Trustees at the Auburn Township Administration Building on September 10, 2024, at 3:30 pm.

**Mr. Dan Matsko, Fiscal Officer**, presented the payment listing for payments processed since August 19, 2024 - listing 4 electronic payments processed for \$32,450.92, and 27 warrants processed for \$369,509.38 totaling \$401,960.30.

Mr. Matsko presented the August bank reconciliation and savings account balances, as of August 31, 2024. The primary checking account balance was \$2,137,647.09. The Star Ohio balance was \$1,201, 605.61.

Mr. Matsko reported the 2022-2023 financial audit has been completed. Preliminary results were emailed to all Trustees last week. A more comprehensive report will be forthcoming once all information has been reviewed.

**OLD BUSINESS:**

Mr. Cavanagh reported that the Public Hearing notice for proposed Zoning Amendment ZC2024-01 Family Cemeteries was not advertised in the newspaper in a timely manner, as required by the ORC. This was due to the recent storm and power outage we had in August 2024.

The proposed amendment will be returned to the Zoning Commission. They can reinitiate it as proposed zoning amendment ZC2024-02. Mr. Cavanagh said even though the information was posted on the Auburn Township website, it was not adequate.

A quote was received from Weaver Tree Company. Mr. Cavanagh said that two other tree companies were contacted, but no written quotes were received. He noted that Weaver had done a good job for the Township in the past.






