The regular meeting of the Auburn Township Board of Trustees was called to order at 7:30 p.m. by Trustee Chairman Michael S. Troyan. All three Trustees were present.

The Pledge of Allegiance was led by Mario Manacci, AVFD President.

GUESTS:

Mr. Mario Manacci, AVFD President spoke about the budget and a new contract, which would include:

- 2.5% Cola increase
- Revised timeline P & L within 60 days March 1, 2025
- Budget review in the spring

Mr. Troyan noted that a portion of the budget was based on 100% staffing, which was never hit. He said they would review the new contract and noted they had to get this done by the next Trustee meeting so the new contract can be approved before the old one expires.

Mr. Ron DiNardo, owner of several parcels of land in Auburn Township - adjacent to Route 422 westbound exit ramp and Route 44, spoke again to the Trustees. On November 18, 2024, he presented the Trustees with a plan for developing his property and building a Circle K. He presented changes to his original plans with a new curb cut. Mr. DiNardo stressed that the Township would be able to utilize their entire property, and his property would have a brand-new access point from Route 44, with very minimal impact to the parcel. Mr. DiNardo felt his new plan would have the least impact to the parcel owned by the Township.

There was a discussion with the Zoning Inspector, Frank Kitko, the Trustees and Mr. DiNardo. Mr. DiNardo then asked the Trustees if they would consider a property swap – he would swap his same sized parcel of land for the parcel the Township owns.

Trustee Patrick J. Cavanagh felt the proposed Circle K was an appropriate use of the property, and thought it was something the Township should consider.

Mr. Troyan asked Mr. DiNardo if he had any other property he would consider swapping with the Township. Mr. DiNardo said he did have some other property on old Washington Street. Discussion ensued.

Mr. Troyan asked for a random sampling from the audience members if they would like to see a gas station at the proposed site. Some audience members said yes. He noted he did not travel that way frequently, so it would not affect him that much.

Trustee Eugene T. McCune Jr. said he was not currently in favor of it. He said there were a lot more things to consider – crime, a restaurant, gas station and diesel trucks moving in and out – making it a truck stop.

Mr. Cavanagh said he would consider the proposal.

Resident Diane Jones commented on the impact Circle K could have on the township now and in the future.

Mr. DiNardo asked if the Trustees could decide within the next week. Mr. Troyan said he doubted they would decide in a week and thought it would take them a month or two to consider everything, and all the ramifications involved.

Mr. DiNardo said he would reach out in 30 days to see if a decision had been made.

SCHEDULED REPORTS:

Mr. Frank Kitko, Zoning Inspector, submitted a Zoning report reflecting 9 applications processed in the month of November 2024.

Mr. Michael Fenstermaker, Highway Superintendent, gave the following report for November:

- Performed various maintenance and repairs to ready the plow vehicles for snow removal.
- Removed branches and downed trees from the roadway.
- Dead deer and racoon disposal.
- Beaver dam removal

TRUSTEE & FISCAL OFFICER REPORTS:

Eugene T. McCune Jr. spoke more on the proposed Circle K, and said he is not opposed to development, but it sounded to him like this proposed gas station is a truck stop.

Mr. McCune reported that Kristen Rine, the attorney for the Township, had a lot of questions about the contract with Hess and Associates Engineering, Inc., and Chip Hess answered all of them. Mr. McCune asked if the Trustees wanted to send the contract back to Kristen Rine, or should they sign it. Mr. McCune felt it would cost approximately \$15,000 to get ready to install a septic system for Auburn Community Park and would take months to go through this process. Mr. Troyan said they would review the changes and decide at the next meeting whether to approve and sign the contract or send it back to Kristen Rine for further review.

Patrick J. Cavanagh reported an issue with an employee in the Road Department and as per the Auburn Township Personnel Policy manual, he and Superintendent Mike Fenstermaker met with the employee on Friday, November 29, 2024.

Motion by Patrick J. Cavanagh seconded by Michael S. Troyan to place James Vannoy on unpaid administrative leave. VOTE: McCune Jr., yes, Cavanagh, yes; Troyan, yes. The motion passed.

Dan Matsko, Fiscal Officer, presented the payment listing for payments processed since November 19, 2024 - listing 7 electronic payments processed for \$262,189.38, and 18 warrants processed for \$13,183.75 totaling \$275,373.13. Mr. Matsko noted the largest of those payments was an annual bond payment to Middlefield Bank. The bond payment was for the fire station and the road garage.

Mr. Matsko presented the following November bank reconciliation and savings account balances totaling \$2,951,770.40 as of November 30, 2024. Primary Checking account balance \$1,734,944.75; Star Ohio balance \$1,216,825.65.

Mr. Matsko spoke with the County Auditor's Office today and asked when there would be a decision made about repayment of the Levy monies. The Board of Revision meets on December 30, 2024, and at which time a decision will be made.

NEW BUSINESS:

Mr. Troyan reported they received a quote from Cable Communications, Inc., for a Cell Antenna Booster for the Service Garage in the amount of \$7,058.74.

Mr. Fenstermaker explained that they do not get cell phone service in the Service Garage Building; the cell phones don't work. All the employees use a Wi-Fi connection, and if Wi-Fi goes down, none of their cell phones work, and there is no way to get in touch with any employee in the Road Department. He explained this Cell Antenna Booster would basically put an antenna on their building and bring cell phone service into the building, so the cell phones work.
