There was no further business.

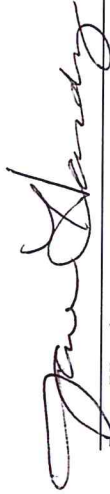
The next meeting will be February 11, 2025, if there is a case.
