The regular meeting of the Auburn Township Board of Trustees was called to order at 7:00 p.m. by Trustee Chairman Eugene T. McCune Jr. Also in attendance were Trustees Michael S. Troyan and Patrick J. Cavanagh.

The Pledge of Allegiance was led by resident Dale Ryan.

GUESTS:

Jim Zuccaro, of Summit Insurance / OTARMA spoke to the Trustees about the new insurance rates for Auburn Township, effective August 1, 2025. The price of insurance for Auburn Township for 2025 – 2026 is \$62,003.00. This is a price increase of \$12,717.98, or about 26% from last year’s rate. Mr. Zuccaro explained that OTARMA, for the second year in a row, and the second time in the history of OTARMA – has had a rate increase. The overall experience in the state has been ‘poor.’ (Note: OTARMA is a self-insurance pool; a non-for-profit association of members joined together for the purpose of sharing losses and spreading risks.)

Mr. Zuccaro explained that every one of the 1048 townships in Ohio are also experiencing the rate increase. He stated the rate increase for some Townships was more than Auburn Township. Trustee Patrick J. Cavanagh noted that the rate increases were across the board, and Mr. Zuccaro concurred. Mr. Zuccaro said the increase was not due to any of the claims by Auburn Township.

Mr. Dan Matsko, the Fiscal Officer, asked Mr. Zuccaro if the invoice could be paid next month, and Mr. Zuccaro said yes. Mr. Zuccaro said he will email Mr. Matsko a Commitment to Continue Membership form that needs signed and returned.

Motion made by Eugene T. McCune, Jr. and seconded by Michael S. Troyan to accept the insurance proposal from OTARMA for insuring Auburn Township from 8/1/2025 to 8/1/2026 in the amount of \$62,003.00. VOTE: Troyan, yes; Cavanagh yes; McCune Jr., yes. The motion PASSED.

MINUTE APPROVAL:

Motion by Patrick J. Cavanagh and seconded by Michael S. Troyan to approve the minutes of the Budget Public Hearing Meeting held on July 7, 2025. VOTE: Troyan, yes; Cavanagh yes; McCune Jr., yes. The motion PASSED.

SCHEDULED REPORTS:

Auburn Fire Department Chief John Phillips presented the monthly detailed report for the Auburn Fire Department. He presented a Year-to-Date Statistics Report comparing 494 year-to-date total calls -January to June 2025 - to 480 total calls in 2024. The percentage of multiple calls was 25.10% for January-June 2025 compared to 22.9% in 2024.

Chief Phillips added that he has submitted a requisition for a video surveillance system upgrade and has selected Visual Armor Security in Painesville, for the purchase and installation of new equipment. The current system was installed in 2012. Their current system is outdated, and they are experiencing problems with it. The new system will cost \$13,960.00.

Chief Phillips said the date for the annual AFD Annual Clam Bake will be held on September 27, 2025, noting the date had changed.

TRUSTEE & FISCAL OFFICER REPORTS:

Mr. Michael S. Troyan addressed the painting/glazing of the windows at Town Hall. Mr. Troyan noted there were 10 big windows, and he would like to evaluate the cost of replacing them, rather than spend \$5600 on painting/glazing, and the repeated maintenance. He thought there could also be energy savings with new windows, and perhaps NOPEC grant money might help to pay for them. The Trustees decided to table the discussion of painting the windows for now.

Patrick J. Cavanagh reported that he and the Highway Superintendent, Mike Fenstermaker, have had ongoing conversations with Mantua Township and both the Geauga County and Portage County engineers, regarding the joint project of resurfacing Crackel Road. Mr. Cavanagh believes Mantua Township is committed to \$300,000 for this project, which will be done in 2 sections. The construction will begin in 2027 and will be one project, done in one calendar year. The total cost of the project is about \$660,000, and Auburn Township will apply for a 50% matching grant.

Mr. Cavanagh reported that they will be applying for a \$2500 Cemetery grant from the Ohio Department of Commerce, Division of Real Estate. The grant is for extreme or abnormal cemetery maintenance projects. It can be applied for every year.

Fiscal Office report - Mr. Dan Matsko, Fiscal Officer, presented the payment listing for payments processed since July 21, 2025 - listing 15 electronic payments processed for \$56,447.76, and 20 warrants processed for \$13,974.20, totaling \$70,421.96.

OLD BUSINESS:

There was no old business.

NEW BUSINESS:

Mr. McCune Jr. read Resolution 2025-12 enabling the Township to place a renewal levy on the ballot. As per the ORC 5705.19(G), this levy is for the general construction, reconstruction, resurfacing and repair of streets, roads and bridges in Auburn Township.

Motion made by Michael S. Troyan. and seconded by Patrick J. Cavanagh to approve Resolution 2025-12, Declaring it Necessary to Levy a Tax in Excess of the Ten Mill Limitation, for 1.00 Mills for each one dollar of taxable value. It is a renewal of an existing 1.00 Mill Levy last voted on in 2020. The levy is to be placed on the ballot at the election held on November 4, 2025, and shall first be levied in tax year 2026 and will begin collection in 2027. VOTE: Troyan, yes; Cavanagh, yes; McCune Jr., yes. The motion PASSED.

The Trustees discussed monies that were available from the Land Acquisition and Improvement fund, as well as from NOPEC, for the Adam Hall roof and the septic system at Auburn Community Park. Fiscal Officer Dan Matsko noted there is approximately \$92,000 in the Land Acquisition Improvement Fund. Mr. Cavanagh explained that NOPEC will not issue the money until there is a project. Mr. Troyan thought the Trustees should pursue both projects.

The Trustees discussed quotes received from JMH Exteriors and Somrack Roofing and Construction for a new roof on Adam Hall. After some discussion, the Trustees decided to have a building professional / engineer look at the roof, before replacing it. Mr. McCune Jr. said they will look at the roof structure intensively before they put on a new roof. Further discussion regarding the quotes received for a new roof on Adam Hall have been tabled.

Motion by Patrick J. Cavanagh and seconded by Michael S. Troyan, to apply the NOPEC Grant Distribution of \$6599.50 to the engineering Auburn Community Park septic system. VOTE: Troyan, yes; Cavanagh, yes; McCune Jr., yes. The motion passed.

Mr. Troyan questioned if this equipment is recommended for Park use; versus residential use, and would it have to be inspected before installation. Mr. McCune Jr. felt the insurance company should be contacted to see if this would be suitable for use in a public park. Mr. Troyan suggested the Trustees table the Tetherball request for now. Mr. McCune Jr. added he has had no one ask him about Tetherball equipment, but he has had a lot of people ask him about Pickleball.


