Mr. McCune Jr. read the upcoming Save the Dates.

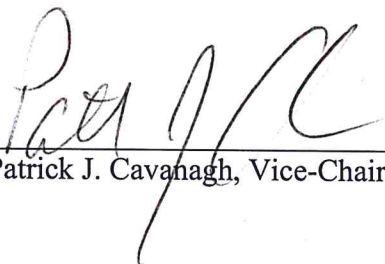
Mr. McCune Jr. noted that he appreciated the opportunity to serve Auburn Township for 16 years and wished Mr. Davis nothing but the best.


**ADJOURNMENT:**

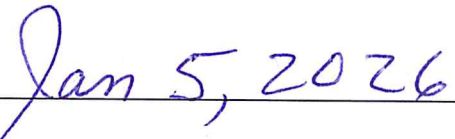
